





Compliments / Complaints

In 2020 the Department received four complaints against personnel. The officer's actions in each of those four cases were found to be within policy.

Generic complaints, such as residents wanting more speeding enforcement, or who wanted to contest a ticket were not recorded as complaints against officers or the Department.

JAN

There were no personnel complaints. 10 employees received compliments.

FEB

There were no personnel complaints. 5 employees received compliments.

MAR

A resident complained that an unknown officer drove too fast and tailgated him through town. He suggested that it might be time to lay officers off work because of COVID. A check showed that the officer was responding to a missing child run. Many employees received compliments out of the response to the flooding.

APR

A resident expressed concern that an officer requested identification from her daughter. 5 employees received compliments.

MAY/JUN/JUL/AUG/SEP

A Millersport resident expressed concern that an officer was not wearing a facemask during a traffic stop.

36 compliments were received on specific employees.

OCT/NOV/DEC

A resident expressed concern regarding an officer who stopped her husband twice for speeding, and the length of the stops. Upon review it was found to be two different officers on two different occasions. The resident received a warning on the first stop and a citation for 53 in a 35 on the second traffic stop.

16 compliments were received on specific employees.

GPD would also like to acknowledge the dozens of cards and letters of report we received during 2020.

Discipline

Several officers and dispatchers received counseling or minor discipline throughout the year for incidents ranging from uniform & equipment care, to improperly completing reports. One employee facing discipline resigned.

The Ohio Collaborative

GPD continued to maintain accreditation through the Ohio Collaborative, and met all standards for 2020. Our next recertification is in 2021. Currently in Licking County only the Granville Police Department and The Licking County Sheriff's Office are fully accredited by the State of Ohio
