**RESOLUTION NO. 2023-06**

**A RESOLUTION TO APPOINT AND (RE)APPOINT MEMBERS TO THE GRANVILLE ARTS COMMISSION**

**WHEREAS**, on March 3, 2004, by Resolution No. 04-19, the Village Council created the Granville Arts Commission to be a “community-based organization dedicated to the enhancement of cultural arts, community character, and interaction;” and

**WHEREAS**, that resolution stipulated that the Granville Arts Commission be comprised of members appointed from the following organizations: Granville Village Council, Granville Township Trustees, Granville Chamber of Commerce, Granville Historical Society, Bryn Du Commission, Granville Recreation District, Granville Foundation, Denison University and one volunteer from the community at-large; and

**WHEREAS**, Angela Katona, the Granville Foundation appointee, term expires on January 31, 2023, and she has expressed an interest in continuing to serve on the Granville Arts Commission; and

**WHEREAS**, the Granville Foundation has recommended to Village Council that Angela Katona be (re) appointed to the Granville Arts Commission with a term commencing on February 2, 2023 that expires January 31, 2026; and

**WHEREAS**, Marilyn Sundin, the Granville Historical Society appointee, term expires on January 31, 2023, and she has expressed an interest in continuing to serve on the Granville Arts Commission; and

**WHEREAS**, the Granville Historical Society recommended to Village Council that Marilyn Sundin be (re)appointed as the representative to the Granville Arts Commission with a term commencing on February 2, 2023 that expires January 31, 2026; and

**WHEREAS**, Neal Zimmers, the Granville Recreation District appointee, term expires on January 31, 2023, and he has resigned his position on the Granville Arts Commission; and

**WHEREAS**, Billie J. Zimmers, has expressed an interest in serving on the Granville Arts Commission as the Granville Recreation District appointee; and

**WHEREAS**, the Granville Recreation District has recommended to Village Council that Billie J. Zimmers be appointed as the representative to the Granville Arts Commission with a term commencing on February 2, 2023 that expires January 31, 2026; and

**NOW, THEREFORE, BE IT RESOLVED** by the Council of Granville, Ohio, that:

**Section I.** Angela Katona is hereby (re)appointed as the Granville Foundation representative to the Granville Arts Commission by Village Council.

**Section II.** Marilyn Sundon is hereby (re)appointed as the Granville Historical Society representative to the Granville Arts Commission by Village Council.

**Section III.** Billie J. Zimmers is hereby appointed as the Granville Recreation District representative to the Granville Arts Commission.

**Section IV.** BE IT FURTHER NOTED that membership of the Granville Arts Commission shall be as follows:


