Permits for tunneling, open cut of pavement, mining or quarrying near, through or under the RIGHT-OF-WAY, overweight crossings, etc. will require a bond in cash or certified check. The bond or certified check shall be posted prior to the issuance of the permit, pursuant to Section 903.02 of the Codified Ordinances of Granville. The bond shall be in the amount determined by the Village Manager and/or his designee, and shall be sufficient in size as to insure the complete restoration of any pavement, drainage, shoulder, structures, sod or other items disturbed by the permittee.

The Village Manager and/or his designee shall have the right to specify working hours on a project where heavy traffic volumes exist or in a case where a hardship will be created if the work is conducted during normal working hours.

ALL WORK REQUIRING WORKERS OR VEHICLES ON THE PAVEMENT OR SHOULDERS SHALL COMPLY WITH ALL THE REQUIREMENTS OF THE OHIO MANUAL OF UNIFORM TRAFFIC CONTROL DEVICES AND ITEM 614 (MAINTAINING TRAFFIC) OF THE OHIO DEPARTMENT OF TRANSPORTATION CONSTRUCTION AND MATERIAL SPECIFICATIONS. FAILURE TO COMPLY WITH THIS REQUIREMENT WILL BE CAUSE FOR IMMEDIATE SUSPENSION OF THE PERMIT UNTIL PROPER TRAFFIC CONTROLS HAVE BEEN PROVIDED.
